

Conditions of Entry

Win flights for two promotion

- (1) The Win flights for two lucky draw Promotion ("Promotion") is organized and managed in Australia by MIL Overseas Limited having its address at Level 4, 10 Spring St Sydney NSW 2000, Australia ("**Promoter**"). The Promotion is open to all residents of Australia aged 18 years and above, except the following:
 - (a) employees (and their family members) of the Promoter, its affiliates and subsidiary companies, as well as agents of the Promoter and their affiliates and subsidiary companies;
 - (b) Agents of Promoter and their employees (and their family members), affiliates and subsidiary companies;
 - (c) anyone else professionally connected with the Promotion.

Family member referred to in these Terms and Conditions includes but not limited to: spouse, ex- spouse, defacto spouse, partner, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.

- (2) The term of the Promotion is from 9.00am Monday 2nd January 2017 to Sunday 12th February 2017, both days inclusive ("**Promotion Period**").
- (3) The Promotion is open to customers who send money through MoneyGram at Vina Money Transfer Pty Ltd. locations in Australia to Vietnam to be collected at any MoneyGram agent location ("**Participating Locations**") during the Promotion Period. No minimum amount is required ("**Qualifying Transaction**").

Any transfer send transaction canceled or refunded to the sender by MoneyGram due to legal, compliance, regulatory or fraud related reasons prior to collection by the receiver will not be counted.

- (4) Every customer will automatically receive one (1) entry into the lucky draws for every Qualifying Transaction conducted to the Participating Locations during the Promotion Period and get a chance to win one of the prizes listed below:
 - a) There will be a total of ten (10) winners chosen via lucky draws conducted on a weekly basis based on the Qualifying Transaction numbers. The weekly draws will be drawn at 3.00pm AEDT on the Tuesday of each new week, starting on Tuesday 10th January 2017 and until the end of the Promotion Period. The winners of the weekly draws will each receive an AUD 50 voucher.
 - b) In addition to the weekly draw, a runner up prize draw will be conducted at 3.00pm AEDT on Tuesday 28th February 2017 whereby two (2) winners will be selected as runner prize winner and each will receive a AUD 500 voucher.
 - c) In addition to the weekly draws, a grand draw will be conducted at 3.00pm AEDT on Tuesday 28th February 2017 whereby one (1) winner will be selected as the major prize winner and will receive two (2) return flights for two people to Vietnam or any other destination of the winner's choice, at a carrier of the Promoter's choice, up to the maximum value of AUD3000 for both tickets combined.
- (5) The winners will be notified by telephone using the numbers provided while conducting the winning Qualifying Transaction, after the relevant draw has been conducted. All reasonable attempts will be made to contact the winners, but if this cannot be achieved within five (5) days after the relevant draw date, the Promoter reserves the right to withdraw the prize entitlement and award the prize to an alternative winner selected at the same time as the original winner or to dispose of the prize as it deems fit.
- (6) The vouchers will be sent directly to the winners via mail up to fourteen (14) days after the relevant draw date.
- (7) The vouchers shall be subject to the terms and conditions of issuer.
- (8) Winners are responsible for tax liability where applicable.
- (9) The prizes are not exchangeable or transferable.

- (10) The winners may be required to take part in publicity related to the Promotion including having his or her photograph taken and his or her name, nationality and country of residence being disclosed without further compensation.
- (11) Winners who do not wish to take part in this Promotion may either communicate the same to the Promoter or decline to accept or collect the prize.
- (12) The Promoter's decision in all matters to do with the promotion is final and no correspondence will be entered into.
