

Conditions of Entry

Win an iPhone X

- (1) The win an iPhone X lucky draw Promotion ("**Promotion**") is organized and managed in Australia by MIL Overseas Limited having its address at Level 4, 10 Spring St Sydney NSW 2000, Australia ("**Promoter**"). The Promotion is open to all residents of Australia aged 18 years and above, except the following:
- (a) employees (and their family members) of the Promoter, its affiliates and subsidiary companies, as well as agents of the Promoter and their affiliates and subsidiary companies;
 - (b) Agents of Promoter and their employees (and their family members), affiliates and subsidiary companies;
 - (c) anyone else professionally connected with the Promotion.

Family member referred to in these Terms and Conditions includes but not limited to: spouse, ex- spouse, defacto spouse, partner, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.

- (2) The term of the Promotion is from 9.00am AEDT Monday 8th January 2018 to 11.59pm AEDT Sunday 18th February 2018 ("**Promotion Period**").
- (3) The Promotion is open to customers who send money through MoneyGram at Vina Money Transfer Pty Ltd. locations in Australia (exc. South Australia) to Vietnam to be collected at any MoneyGram agent location ("**Participating Locations**") during the Promotion Period. No minimum amount is required ("**Qualifying Transaction**").
- (4) Any transfer send transaction canceled or refunded to the sender by MoneyGram due to legal, compliance, regulatory or fraud related reasons prior to collection by the receiver will not be counted.
- (5) Every customer will automatically receive one (1) entry into the lucky draws for every Qualifying Transaction conducted at the Participating Locations during the Promotion Period and get a chance to win one of the prizes listed below:
- a) A runner up prize draw will be conducted at 3.00pm AEDT on Wednesday 28th February 2018 whereby ten (10) winners will be selected as runner prize winners and each will receive an AUD399 Apple voucher.
 - b) In addition to the runner up draw, a grand draw will be conducted at 3.00pm AEDT on Wednesday 28th February 2018 whereby two (2) winners will be selected as the major prize winners and each will receive one (1) iPhone X (64GB), valued at AUD1579 each.
- (6) The winners will be notified by telephone using the numbers provided while conducting the winning Qualifying Transactions, after the relevant draw has been conducted. All reasonable attempts will be made to contact the winners, but if this cannot be achieved within five (5) days after the relevant draw date, the Promoter reserves the right to withdraw the prize entitlement and award the prize to an alternative winner selected at the same time as the original winner or to dispose of the prize as it deems fit.
- (7) The iPhone X's will be sent directly to the winner via courier up to fourteen (14) days after the relevant draw date.

- (8) The vouchers will be sent directly to the winners via email up to fourteen (14) days after the relevant draw date.
- (9) The vouchers shall be subject to the terms and conditions of issuer.
- (10) Winners are responsible for tax liability where applicable.
- (11) The prizes are not exchangeable or transferable and are not convertible to cash.
- (12) If the prizes are unavailable, for whatever reason, the Promoter reserves the right to substitute the prizes for other prizes of equal or greater value.
